2. Business Activity Update:

- Godwin's Market is now open. They are planning additional services for our community.
- BBQ Restaurant Hopefully open by middle of May 2023. Also planning to have baked goods & ice cream deli.
- 3. Town Budget for FY 2024 Have held workshops looking at Long-term needs Salaries, Fire Truck, buildings for fire & police departments and other staffing requirements. Current town ad valorem tax rate: 34 cents per \$100 valuation. We are currently about \$400,000 from a draft balanced budget for FY 2024.

do not put firefighters on a metal roof like you do with a conventional asphalt shingle roof for safety reasons and we now have homes with rescue needs from higher floors. The ability to put water above and down onto a fire also reduces the spreading of a fire. It is about your safety, safety of neighbors homes and about the safety for our firefighters. Current requirements also require the replacement of your first line truck at 20 years. Our first line fire truck turns 20 in 2030. There is a lead time of up to 3 years to build a fire truck. This says we have to be ordering a fire truck by 2026/27.

- 5. <u>Topsail Beach Logo License Plate</u> Representative Carson Smith has submitted a local bill for our logo plate and we now wait for bill to move through the legislative process.
- 6. Legislative & State Committee Activities to Follow:

- 7. Paid Parking We continue to obtain feedback from property owners. We expect a decision for a way forward during the May Commissioners' Meeting on May 10. Over 75% of Topsail Beach's streets are state maintained with 20 to 60 foot Right of Way (ROW). Many of our businesses including rentals use ROW for all of their parking needs. - 8. <u>Conditional Zoning Request for South-end</u> The Application has been ruled complete. The Town has started to receive feedback from state & federal agencies. The Planning Committee will be seeking public comments at their April meeting. The Planning Committee has until May 30th to make their decision.
- 9. Town's Land Use Plan (LUP) Update We will continue to ask for public comments in May's Commissioners Meeting. Public Hearing is scheduled. - 10. <u>Topsail Beach Nudity Ordinance</u> Our attorney has provided a draft ordinance he feels is enforceable and will be upheld in our courts. We expect a decision on this ordinance in our May Commissioner Meeting. Please provide feedback on how you believe we should proceed. - 11. <u>Vitex</u> This plant is an invasive plant and does not add strength to our dune system as other plants and grasses. The island's 3 Towns are coordinating efforts to remove Vitex; it is expected this will be a 3 year project. First used as a beach-stabilization plant in South Carolina in the 1980s. Labeled a problem invasive species around 2000. THREAT: Prolific seed producer and fast grower; crowds out native beach plants; impedes sea turtle and shorebird nesting; doesn't stabilize dunes. - 12. Beach Clean This program is coordinated by the Topsail Island Shoreline Protection Commission for the 3 island towns. We are seeing increasing amount of waste on our beaches with the impact of micro plastics. The 3 island towns have banned the use of non encapsulated polystyrene in floats for new docks and dock repairs. With the increasing visitors, we need to educate the public about "leaving no trace" on our beach. We have also been asked to ban the release of balloons because of their impact on wildlife. The towns will need to consider what are the proper steps for balloons. Please help by reminding all to help protect our waterways. A micro plastics report can be found here:

 - Preserve the beach and sound for their recreational value and natural beauty, which provide Topsail Beach with its identity.
 - Encourage investment into the maintaining and enhancing the central business district, particularly through additional small-scale shops and food service options.
 - Maintain the Town's small-town character, generally consisting of low density single family residential development.
 - Ensure the future resilience of the Town through coastal storm damage reduction and beach protection efforts.
 - Enhance bicycle and pedestrian facilities to provide safe options for non-motorized transportation and recreation
